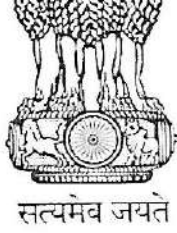

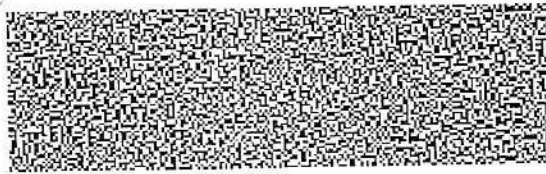
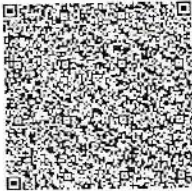

MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of understanding (MOU) is made and executed on this 2nd Day of June 2022 at Bengaluru, Karnataka, by and between First Party and Second Party as mentioned in the table below;

Hereinafter both First Party and Second Party referred to as the Parties.

Whereas First Party will collect dry recyclable waste under the Wellbeing out of Waste (WOW), an initiative of ITC, through its super franchisee and waste paper will dispatches to ITC - Paperboards and Specialty Papers Division (PSPD), Unit Kovai, for recycling. Plastic waste / other waste materials will dispatch to authorized vendors / recyclers.

Whereas, the Second Party has agreed to give away the waste paper and plastic waste collected by its students, Volunteers, school management. The collection of dry recyclables from the Second Party will be initiated from as per schedule, where both the parties have agreed mutually.

NOW THIS MOU WITNESSETH AS UNDER:

This MOU is intended to create a synergic alliance between both the Parties for the recycling dry-waste, which is a vital element in the protection of environment

1) Definitions:

- a) **Wastepaper:** Discarded white paper, note books, text books, exam answer sheets, question papers, project work papers, cardboard, newspaper and magazines, shredded white papers, etc.
- b) **Plastic waste:** Water bottles, pet bottles, High value Plastic (HDPE) etc.,
- c) **Other Waste:** Metal, Copper and other waste items.
- d) **E- Waste:** Electrical and Electronic equipment (Ex: Computer, Laptop, Phone, Fridge, LCD TV and etc.,)

2) Quality & Quantity

- a) Material should be free from food particles, without any contamination of garbage, municipal waste or any item which are detrimental to WOW initiative.

3) Roles and Responsibilities of the Second Party

- a) Shall identify the quantum of wastepaper and plastic generated at its various Branches/ locations.
- b) Would store the all types of waste in a segregated manner in their premises safely and First Party would pick up on mutually agreed schedule.
- c) Agrees to appoint its representative to coordinate on various activities identified in MOU as per annexure -1 : Table-1, and to notify First Party within a week of any change in responsibility.
- d) Security has the right to check/ investigate the transporter vehicle while carrying the waste papers and plastic waste for First Party.



4) **Roles and Responsibilities of First Party:**

- a) Shall pay the second party for material collected as per cost card agreed in the annexure -1: Table - 2.
- b) Make necessary arrangements for collecting the wastepaper, plastic & transporting to its godown / Hub Center.
- c) Shall not use or disseminate any confidential information printed on the wastepaper to any third party.
- d) Providing paper recycling certificate (soft copy) from ITC WOW to your esteemed School / college / institution within a month.

5) **Payments:**

- a) A sale invoice in the name of **Super franchisee** shall be issued with local applicable GST by second party to enable payment from Super franchisee up on receipt of Invoice along with Weighment Slips within two days. or
- b) Statement of bills shall be provided to First party by second party for the immediate payment through Cash / online payment, UPI methods.
- c) In case of delay of the payment, may escalate to ITC WOW officials as per annexure table-1,

6) **Roles and Responsibilities in General:**

- a) The details laid out in this MOU, notwithstanding the essence and spirit of this MOU is an understanding between **First party and Second party**.
- b) Any notice or other communication under or in connection with this agreement shall be in writing in the English language and shall be delivered personally or sent by way of e-mail to the party due to receive the notice or communication at its address set out in this contract or such other address as either party may specify by notice in writing to other.

7) **Execution of this Agreement shall be deemed to be;**

- a) A confirmation by both the parties that no benefit, either in cash or kind has been provided by either party to the other party or to any officer or employee, or any relative/ associate of any officer or employee of either party or of any of their associate institutions/organization in order to enter into this Agreement, and
- b) An undertaking by both the parties not to provide any benefit, either in cash or kind to any officer/employee/relative/associate of any officer or employee of either party as reward or consideration either for entering into this MOU or other matter relating to this Agreement.

8) **Other Terms:**

- a) Force Majeure: Neither party shall be liable for damages for any delay or failure to perform its obligations hereunder, if such delay or failure is due to reasons beyond the control of the concerned party including without limitation, strikes, riots, wars, fires, epidemics, quarantine restrictions, unusually severe weather, earth quakes, explosions, acts of God or state or any public enemy or acts mandated by

applicable laws, regulation or order, whether valid or invalid, of any Governmental body.



MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (herein after called as the 'MOU') is entered into on this the 28th day of September month 2022 (Date 28-09-2022), by and between **ExcelR Solutions**, (here in after referred as 'First Party')

And

S.E.A College of Science, Commerce and Arts
K.R. Puram, Bangalore

(herein after referred to as "Second Party",
(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:

1. First Party is a EdTech company: ExcelR Solutions
2. First Party & Second Party believe that collaboration and cooperation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.
3. The Parties intend to cooperate and focus their efforts on cooperation within the area of Skill Based Training, Education and Research.
4. Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

**NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL
PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO
AGREE AS FOLLOWS:**

CLAUSE 1: CO-OPERATION

5. Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings.
6. First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to the second party in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.
7. The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.
8. ExcelR would be the training delivery partner for the second party on various trending technologies
9. Training & Development and dissemination of knowledge for students of second party & affiliated colleges and employees of both the organizations.
10. ExcelR would work with incubation centers/ innovation cells of second party(Case to case basis), to formulate the business cases and data collection process from various industry and academic bodies that are associated with the second party
11. Cooperation between both parties would be extended to any other area which may be mutually beneficial to both organizations.

CLAUSE 2: SCOPE OF THE MoU

12. The budding graduates from the institutions could play a key role in the technological up-gradation, innovation, and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
13. Curriculum Design: First Party will give valuable input to the Second Party in teaching/training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.
14. Software Technologies Training: The first party will provide the training to the students and Faculties of the second party on different technologies like Data Science, Data Analyst, Artificial Intelligence, Tableau, Python, etc., Research and Development
15. Skill Development Programs: First Party to train the students of the second Party on the emerging technologies in order to bridge the skill gap and make them industry ready.
16. Guest Lectures: First Party to extend the necessary support to deliver guest lectures to the students of the second Party on the technology trends and in-house requirements.

17. Faculty Development Programs: First Party to train the faculties of the second Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
18. Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein
19. There is no financial commitment on the part of the second party to enroll the students and faculties for the different free trainings run by the first party under Everyday Learning Initiation.
20. The first party would extend the help in providing artifacts such as training records and certificates to the second party upon a written request from the second party. This information is limited to only the students of the second party and at the discretion of the first party.
21. In case, the second party wants to conduct customized commercial training then this agreement can be amended, adding an annexure with mutually agreed terms.

CLAUSE 3: INTELLECTUAL PROPERTY

22. The first party will have the sole rights on the curriculum and related content provided in the training and it cannot be replicated or copied without the consent of the first party.
23. Confidentiality: Except as may otherwise be required by law, each party will hold confidential, during and after the term of this Agreement, any confidential information disclosed to it or its representatives, and will not disclose any such confidential information to any third party.

CLAUSE 4: VALIDITY

24. The period of the agreement is valid for a period of 2 years from the date of signing of this agreement
25. This agreement will be valid only at the intentions of the parties involved therein, this MOU could be dissolved or cancelled by either party any time by giving 30 days' notice and shall not have any legal bindings in nature. should either or all the parties to it opt to not act upon, the MOU loses its validity.

CLAUSE 5: RELATIONSHIP BETWEEN THE PARTIES

26. It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.



11. The complete list of Students of the course shall be provided to the First Party by the Second Party. Changes in Students, if any, shall be communicated by the representative of the Second Party to the First Party immediately.

12. It is intended that the terms of this MoU will remain in force for an initial period of three years set out above i.e., the completion of First Batch or is otherwise terminated in accordance with the provisions of Clause (13). The MoU can be extended for further periods after the expiry of three years upon the parties mutually agreeing such extension

in writing. The terms of this Memorandum may be modified at any time by both parties on mutual consent.
