#### 4. REVENUE SHARING

 All the revenues generated from the prescribed course fees can be handed over to CATD Academy as per the above-mentioned revenue sharing, with 50% in advance or after 50% after the course is scheduled and 50% balance after the course completion.

### 5. DISPUTE RESOLUTION

Any claim, controversy or dispute arising out of or under this MOU, not settled by mutual agreement of the Parties involved within 15 days after a Party is provided written notice for settlement thereof, shall be referred to arbitration. The arbitration shall be conducted by one arbitrator, and failing mutual agreement between the parties in respect of the appointment of the sole arbitrator within a period of 30 (thirty) days, by three arbitrators who shall be appointed as follows: one nominated by the First Party, and one nominated by the Second Party and the other chosen by the 2 (two) arbitrators so nominated by the Parties. The arbitration shall be conducted in accordance with the Indian Arbitration and Conciliation Act of 1996. The arbitration proceedings shall be conducted in Bangalore, India and shall be governed by the laws of India. The language of the arbitration shall be English. The arbitral award shall be delivered not more than 6 (six) months from the date of initiation of the proceedings. The Parties agree that until the arbitration proceedings are complete, they shall not take their disputes to a court of law. The costs and expenses shall be as awarded by the arbitrators.
