This Memorandum of Understanding (MOU) is entered into on the April 30th 2022 sets for the terms and understanding between the SEA College of Science, Commerce and Arts, Ekta Nagar, Virgo Nagar Post, K.R. Puram, Bangalore-560049.) And SAKHI Trust, Opp Vassavi school, Sri Hari Sirivasam Nilaya, Aravinda Nagar, Hospet-583201, Bellary District.

1. Objective of the MOU

The objective of the MOU is:

- To promote and enhance academic interest between SEA College of Science, Commerce and Arts and SAKHI Trust.
- To encourage the students to improve the academics
- To promote research or continuing education activities between institutions.

2. Area of collaborations

- Provide necessary help in Organizing personality development programs and skill development staff and students.
- Provide academic interaction between social service and special lecture topics.
- Provide the necessary support for skill development and research activities.

3. Propose of collaboration

SEA College of science, Commerce and Arts and SAKHI Trust, purpose of collaborate through the following.

- Cooperation and promotion of education and training area of mutual interest.
- Any other important mode of interaction agreed upon SEA College of science, Commerce and Arts and SAKHI Trust.

A specific plan will be worked out by the institute depending upon availability of recourse. A specific agreement will be entered into for each other.

4. Terms and Conditions

- The cost of development of infrastructure at SEA college of Science, Commerce and Arts should be borne by SEA college of Science, Commerce and Arts.
- For continuing education to SEA college of Science, Commerce and Arts teachers and students, the financial arrangement will be made mutually agreed terms.
- For the visit related to advice, travel and other expenses of SAKHI Trust reimbursed by SEA college of Science, Commerce and Arts on mutually agreed terms.
- Both institution and SAKHI Trust agreed to help, identify and invite the faculty members and research activates.
- This SAKHI Trust may be amended, renewed and terminated by mutual written agreement of the institution at any time.
- Either institute shall have the right to terminate this SAKHI Trust upon 60 days prior written notice to the SAKHI Trust.

5. Confidentiality

- The SEA college of Science, Commerce and Arts and the SAKHI Trust agreed to hold in confidence all information/ data designated by the institute as being confidential which is obtained from either institute or NGO during the performance of the SAKHI Trust and will not disclose the same to any third party without written consent of the other institute.
- The above confidential clause under this SAKHI Trust excludes the information/data possessed by either institute or SAKHI Trust before entering into this SAKHI Trust or independently developed and /or information already available through public domain.

6. Duration

This MOU, unless extended by mutual written consent of the institute, shall expire in three years after the effective date specified in the opening paragraph. However, on review, the SAKHI Trust shall be extended for another TWO years by mutual consent.

7. Coordinators

Both institute and SAKHI Trust will designate persons who will responsibility for co-ordination and implements of this agreement.

8. Signed in duplicate

This MOU is executed in duplicate with each copy being an official version and having equal legal validity. By signing below, the institute and SAKHI Trust acting by their duly authorized officers have caused this Memorandum of Understanding to be executed, effective as of the day and year first above written.
