operation of the joint venture, whose purviews are as mentioned in this memorandum of understanding.

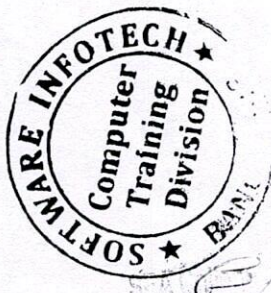

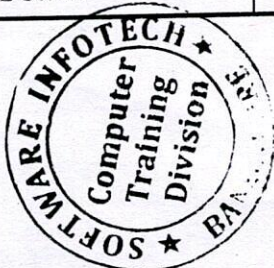

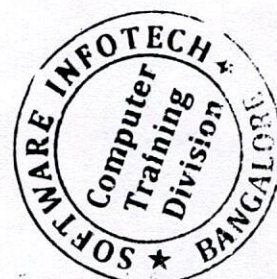
